BALLET TECH FOUNDATION, INC. SUPPORTS THE CREATION AND PRESENTATION OF NEW BALLETS BY CHOREOGRAPHER ELIOT FELD, AND OPERATES THE BALLET TECH SCHOOL. THE SCHOOL IDENTIFIES TALENTED CHILDREN IN NEW YORK CITY'S PUBLIC SCHOOL SYSTEM AND PROVIDES THOSE MOST TALENTED WITH TUITION-FREE PROFESSIONAL BALLET TRAINING.

DURING THE YEAR ENDED 6/30/17, BALLET TECH PRESENTED A ONE WEEK SEASON AT THE JOYCE THEATER IN NYC. THE JUNE 2017 SEASON WAS ATTENDED BY 2,487 PEOPLE, AND INCLUDED TWO NEW BALLETS BY GUEST CHOREOGRAPHERS. THE SCHOOL AUDITIONED 25,231 STUDENTS, WORKED WITH 194 COOPERATING PUBLIC SCHOOLS THROUGHOUT NEW YORK CITY AND ENROLLED A TOTAL OF 727 STUDENTS. 549 BEGINNERS TOOK INTRODUCTORY BALLET CLASSES FOR UP TO 12 WEEKS. 149
