THE SCHOOL IDENTIFIES TALENTED CHILDREN IN NEW YORK CITY'S PUBLIC SCHOOL SYSTEM AND PROVIDES THOSE MOST TALENTED WITH TUITION-FREE PROFESSIONAL BALLET TRAINING.

DURING THE YEAR ENDED 6/30/19, BALLET TECH PRESENTED A ONE WEEK SEASON IN THE SPRING OF 2019. THE SEASON - AT THE JOYCE THEATER - WAS ATTENDED BY 2,377 PEOPLE.
