THE SCHOOL IDENTIFIES TALENTED CHILDREN IN NEW YORK CITY'S PUBLIC SCHOOL SYSTEM AND PROVIDES THOSE MOST TALENTED WITH TUITION-FREE PROFESSIONAL BALLET TRAINING.
